## **CORRIGENDUM TO RECRUITMENT NOTICE**

**Recruitment Notice for filling up 01 Post of Laboratory Assistant vide no. 1329-1331 dated 26.07.2022.**

This is corrigendum to Recruitment notice mentioned above, published in various newspapers (i.e. Hindustan times and Amar Ujala- Chd. Addition on 27.07.2022) and website <https://gmag.chdadmnectt.in> on 02.08.2022 for filling up 01 post of Laboratory Assistant 'Group C' in Govt. Museum and Art Gallery, Sector 10-C, Chandigarh.

It is informed that Department of Personnel, Chandigarh Administration vide letter No. 28/17/94-IH(7)-2022/12577 dated 05.08.2022 has stated that by virtue of notification No. G.S.R. 230 (E) dated 29.03.2022 issued by the Government of India, Ministry of Home Affairs, Conditions of Service of the employees of Union Territory, Chandigarh have been changed from Punjab pattern to Central pattern w.e.f. 01.04.2022. The framing, finalization and notification of fresh recruitment rules on central pattern is a lengthy process and will take considerable time as Chandigarh Administration is in process of finalizing the pay scales of various posts in terms of notification dated 29.03.2022 ibid. It will not be fair to keep the matters like appointment (direct/promotion/deputation), probation, confirmation etc. in limbo till the Recruitment Rules are finalized as per Central Rules. Non-filling up of posts may lead to posts falling in "Deemed Abolished" category, which will adversely affect the working of Chandigarh Administration. Further, employees eligible for promotion will be deprived of their promotional avenue which will tantamount to stagnation in the feeder cadre. Keeping in view of above circumstances and in order to run the affairs of Chandigarh Administration efficiently, Chandigarh Administration has decided to allow operation of Recruitment Rules (as applicable before 01.04.2022) for filling up the posts by way of direct recruitment/deputation till fresh recruitment rules are finalized as per Central Rules.

As per above decision of Chandigarh Administration the following service conditions will be applicable to this recruitment of 01 post of Laboratory Assistant in the Govt. Museum & Art Gallery, Sector 10-C Chandigarh as under:-

1. The age limit for the post of Laboratory Assistant is 18-37 years (Relaxable for Govt. Servant upto 05 years in accordance with the instructions of Govt. of India). Age is to be calculated on 01.01.2022.
2. Period of Probation: During the Probation period of 03 years, newly recruited employees will be paid "Fixed Monthly Emoluments which will be equivalent to the minimum of the pay band/matrix of the post or DC rate, whichever is higher during three years period of probation and the extended period of probation, if any. No increment or any other allowances except travelling allowance will be payable".
3. The last date for apply online is extended to 30.08.2022 and the last date of fee deposit is extended to 02.09.2022
4. The above service conditions are subject to further revision (if any) upon the latest instructions issued by Chandigarh Administration from time to time.
